We are communicating with you in regards to several matters relating to the forthcoming Diocesan Synod which will take place in Sault Ste. Marie, from Thursday morning, May 9, 2019, to 1:00 pm on Saturday, May 11, 2019.

As we have not yet been advised of all of the names of elected Lay Delegates, we are requesting our Incumbents share this memorandum with the elected delegates, and their names be forwarded to us as soon as they are determined.

### **CONVENING CIRCULAR**

In accordance with Section C, Article 4, of the Constitution, the Convening Circular will be posted to the diocesan website at [www.dioceseofalgoma.com](http://www.dioceseofalgoma.com) one month before the meeting of Synod, and this date has been scheduled for the week of April 8, 2019. We also wish to draw your attention to the provision of Article 11 of the Constitution, which provides for proper notice in the Convening Circular of any amendments or alterations to the Constitution and Canons. Any such Motions should, therefore, be submitted immediately in order to ensure their inclusion in the Convening Circular.

### **TRAVEL COSTS, ACCOMMODATIONS, MEALS ETC.**

Would you please note that the Parish is responsible for these costs. Executive approved a synod site fee for each delegate to cover one lunch and coffee breaks in the amount of \$50. Parishes will submit the fee for each lay and clergy delegate with the certificate of election of lay delegates.

Insofar as Retired Clergy and Youth Delegates are concerned, we will be writing to them by separate communication under today's date.

### **ACCOMMODATIONS**

Arrangements have been successfully concluded with the Water Tower Inn and all Synod Sessions will take place at that establishment.

In the past, considerable and unnecessary work has been caused by asking the Synod Office to arrange for accommodation, and we would suggest that you make your own reservations directly. ### **REGISTRATION**


